



## Previous Community Investments

At Marshfield Clinic Health System, we focus on enriching lives by helping people and communities achieve their best health. Since 2012, Security Health Plan, an entity of Marshfield Clinic Health System, has offered community health grants supporting local initiatives, programs and processes that address community health needs. Beginning in 2018, Security Health Plan and Center for Community Health Advancement began collaborating on these community health grant opportunities. We offer this recap of that work.

### **2019: Youth E-cigarette Prevention Catalyst Stipends**

Marshfield Clinic Health System awarded thirty-eight catalyst stipends to a broad cross-section of organizations, including school districts, health departments, law enforcement agencies, local coalitions and tribal communities to address the growing concerns about the health implications of e-cigarette use among our youth.

Project areas covered community awareness events, coordination with state policy initiatives, curriculum development and the implementation of youth-led action plans to address e-cigarette use in schools in over 30 counties.

### **2018: ABCS for Healthy Communities**

Marshfield Clinic Health System and Security Health Plan partnered to offer up to \$300,000 in grants to communities to help strengthen the ability of communities to influence the health of their residents by reducing and preventing health issues and health inequities. This ABCs for Healthy Communities grant program focused on: A) alcohol and other drug abuse; B) behavioral health; and C) chronic diseases.
